2. Overview of Learning Attainment Evaluation (self-evaluation)

a) Purpose

The Graduate School of Integrated Sciences for Global Society has established 11 skills that each student should master through their learning and research activities by the time they complete the two-year Master's Program.

Starting with students admitted in Spring 2019, we have provided the Portfolio for Studying and Advising with a system for Learning Attainment Evaluation. This is used to evaluate degree of mastery over time, i.e., the degree to which the 11 skills have been acquired at each point in time. The purpose is to provide an opportunity for each student to examine their own learning situation, promote appropriate guidance by advisors, and improve the quality of education and the curriculum at the Graduate School.

Input can be done easily using the Portfolio system. We ask that all of you provide input to help us continue to improve the quality of education of the Graduate School.

b) Precautions

(1) Learning attainment evaluation is carried out for the purposes of self-improvement by each student, evaluation by advisors, and improvement of education quality. The results are not incorporated into study records, grade transcripts, or any other student records.

(2) Records of self-evaluation by students can be viewed by supervisors.

(3) Please understand that data for each student will be aggregated and analyzed anonymously, and used to discover any issues in Graduate School education and for improving the curriculum.
